

Installation manual category R (mudguards with Radius 40/40)

General:

This installation manual is intended for assembly of De Haan steel mudguards type coding R / HMR / THMRV / THMRD / TRV / TRW.

The mudguards are exclusively intended for use of category O1 and O2 vehicles.

Before installation and first use of the mudguard, the installation instructions should be read carefully.

The installation must be carried out correctly and exclusively by a competent person.

Preparation:

Wear gloves at all times when handling the mudguard. The mudguard has sharp edges on the installation side.

Make sure you have the correct tools for assembly.

Take note of guidelines 91/226 / EEC - 2010/19 / EU and mount the mudguards according to the requirements specified herein.

Mudguard installation using brackets:

This type of installation is ideal for mudguards with Radius 40/40.

Use at least two brackets with a width of minimum 30 mm. The mudguard must be fixed both at the front and at the rear bracket with at least 2 screws. Make sure these won't come loose due to vibration of the trailer/mudguard.

Assembly tools are not included.

maintenance:

The mudguard should be cleaned with clear water after contact with dirt or salt. Never overlay a wet mudguard. Never put any weight on the mudguard.

After some time the mudguard will shine less. This is a natural process and does not affect the quality of the material.

The mudguard should be replaced when the original form is affected due to damage.
